



## COVID-19 Protocols and Guidelines – Summer 2021

- **Policies and Procedures:**

- All eligible staff members are vaccinated.
- Require consistent and correct use of well-fitting face masks with proper filtration by all campers, staff, and visitors.
- Plan in place for campers to stay in cohorts (small groups) with dedicated staff and remain with the same group throughout the morning, every day.
- Camp policies and strategies in use to promote physical distancing, indoors of:
  - Three feet between all campers within a cohort.
  - Six feet between cohorts at least 6 feet while eating and drinking, including among individuals within the same cohort.
  - Six feet between campers and staff.
  - Six feet between staff during period of time when they are together.
    - Activities planned that can take place outdoors such as crafting and snack.
    - Plan in place for where and when campers eat snack with their cohort.
    - Spaces are well ventilated and large to allow for social distancing and “masks off” when eating (if this has to take place indoors due to weather).
- Procedure in place for daily temperature checks of all campers and staff.
- Plan in place for if students feel ill.
  - Student will be isolated in our “sick area” and a parent or guardian will be called after proper assessment of a camper’s symptoms.

- **Facilities and Supplies:**

- Designated areas for students’ belongings.
- Physical guides (social-distance spots) and arrows have been provided on all floors to improve traffic flow and distancing measures.
- Adequate supplies will be prepared to lessen sharing of materials between cohorts.
- Supplies obtained including:
  - Paper towels
  - Hand sanitizer (at least 60% alcohol)
  - Extra masks
  - Hand soap
  - Cleaning and disinfecting supplies

- **Staff Education and Training:**

- Point person for all COVID-19 related concerns is the Center Stage Theatre Education Supervisor.
- Staff is well-versed in all guidelines and procedures related to our programming and COVID-19.
- Plan in place to educate staff, campers, and their families about when they should stay home and when they can return to camp.
  - Campers should stay home if they:
    - Have COVID-19 symptoms.
    - Have been diagnosed with COVID-19
    - Are waiting for COVID-19 test results.
    - Have been exposed to someone with symptoms or a confirmed or suspected case
  - Fully vaccinated asymptomatic people can refrain from quarantine, but should continue to monitor symptoms for 14 days following exposure.
- Plan to teach and reinforce consistent and correct use of masks.
  - Staff will provide information on proper use, removal, and washing of masks.
  - Plan in place for teaching the importance of physical distancing and staying with small groups (cohorts).
  - Plan in place for teaching the importance of handwashing with soap and water for at least 20 seconds as well as a plan to do so at the beginning and conclusion of each class.
